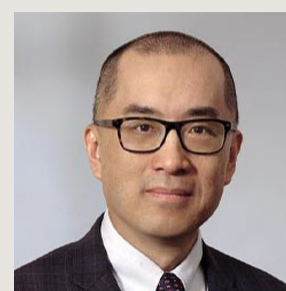

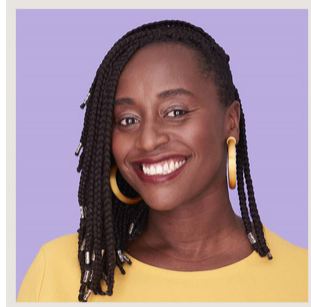
New Certificate Focuses on Managing Supply Chain Risks and Sustainability

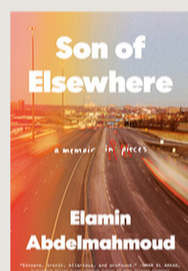
