Independence in decision-making is an essential aspect of administrative justice, and administrative decision-makers are expected to adjudicate in accordance with their own consciences and opinions. A key feature of administrative independence is the extent of permitted consultation within tribunals about important issues of procedure, law and policy. Thirty years ago the Supreme Court issued its seminal decision in IWA v. Consolidated Bathurst Packaging Ltd., authorizing administrative tribunals to hold full meetings to discuss broad issues of policy without breaching the rules of natural justice. It is now well accepted that Internal tribunal discussions enable members to benefit from the collective experience of all members and ensure uniformity of tribunal decisions. How can internal tribunal processes be facilitated without fettering the discretion of tribunal members?
