## Program Format

The Professional LLM in General Law requires completion of 36 credits including a research requirement. The program is designed to be completed in two years (six active terms) by completing 6 credits (one or two courses) per term. While new students are admitted every Fall and Winter, some specializations may only be incorporated at specific times, according to when their required courses are held.
