Keynote: Judge Jed Rakoff, Senior U.S. District Judge for the Southern District of New York

The keynote address will be delivered by **Judge Jed Rakoff**, who has sat on the United States District Court for the Southern District of New York since 1996. One of the oldest and most active trial courts in the United States, this Court often has jurisdiction over the largest financial institutions in America.

Judge Rakoff has authored over 1,800 judicial opinions, with his most noteworthy decisions being in securities law and criminal law. He frequently sits by designation on the 2nd and 9th Circuit Courts of Appeals. In addition to his judicial writing, Judge Rakoff has written over 190 articles, 900 speeches, and has co-authored six books.

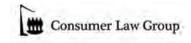
