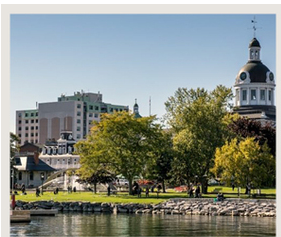


New Osgoode One-Day Program Helps Build Practical Knowledge and Community Among Medical Research Law Professionals
